The bids will be publicly opened and read at 10:15 AM. The awarding of bids may be made at the next regular of the Board of County Commissioners following the opening of the bids.

All proposals shall be made in accordance with forms and specifications attached to and made part of this invitation to bid. Bids may be accompanied by a certified check, cashier's check, or a bank draft, issued by a State or National Bank domiciled within the state, and payable to the Minnehaha County Treasurer in an amount equal to five percent (5%) of the amount bid, or a bid bond of ten percent (10%).

By virtue of statutory authority, preference will be given to material, products and supplies found or procured within the State of South Dakota. A resident bidder is allowed a preference as against the bid of any bidder from any other state enforcing or having a preference.

The Board of Minnehaha County Commissioners reserves the right to waive any irregularities deemed advantageous to the County, to reject any and all bids, and to negotiate with the most qualified individual or firm submitting a proposal.
